
What's New

1. TaskMax - Reference number added to DocMax


The reference number of the Workorder when finalised in TaskMax will now include the reference number in the DocMax title which will be upload to the portal.

When 'Enable Saving Work Order to DocMax settings" is enabled in TaskMax, finalised workorder will be saved into DocMax automatically with the creditor name and reference number of the Workorder.

Finalised Workorder in TaskMax example




Stored Document in DocMax now showing the reference number matching TaskMax example.



2. Levy Management - Manual Levies Determined Date

When entering manual levies the 'Determined Date' is now available on the user interface for users to enter or edit the Determined Date which may appear on Levy Notice if the template outputs a determined date.


Please Note – The Determined Date will default to today's date. If the Determined Date is what is to appear on Certificates when Approved, please make sure that the approved date is changed to match this date.



3. Report Distribution – Show Arrears

Show arrears option is now available in Report Distribution when distributing levies as a global setting.

Please Note – This setting is on by default and should be checked on your first levy run after update to 5.6.140 if you require the setting to be unchecked.



4. New ATO SBC Client version

The ATO is updating their systems to improve security, and from early next year they will only accept connections using the newer TLS 1.3 standard. TLS (Transport Layer Security) is the encryption layer user for communication with the ATO.

Please contact StrataMax Support to arrange an update to your SBR Client installation. Please note your IT provider may need to be involved to perform the upgrade on the required computers.

What's Better

- Levy Invoice Code Setup The Discount Codes will no longer appear on the Levy Invoice Code Setup / Bulk Edit Posting Priority. This is now resolved.
- Dashboard /Levies not Printed The number of Levies not printed did not equal
 the Levies not printed report due to Prior Manager Levies being included. Prior
 Manager Levies are no longer included in the Levies not printed report.
- Change Of Entitlements/Resubdivision module The Reverse Option will now hold the set tick if user goes back after ticking the reverse options, screen will now show all columns and is more visible to the user all information on the screen. The system will now exclude prior resubdivision adjustment levies from following resubdivision and change of entitlements will be reported correctly fort calculations of new levies/adjusted levies.
- Levy Register If a Levy had been edited the Net Due was reporting incorrectly on the Levy Register Report. This has now been resolved.
- Levy Management When opening a report from Levy Management and changing the building number in the report, it was negatively affecting future actions in the levy management screen - This scenario has been resolved.
- Levy Management If a Levy has been edited the Net Due was reporting incorrectly on the Levy Register Report. This has now been resolved.
- Levy Management Editing an un-generated levy where re-subdivision had been initiated was causing an error. This has been resolved.
- DocMax Document Properties/ Creditor selection The selection options available for creditors in DocMax will now match the account selection in Creditor Invoice Entry. Options for example Preferred Creditors, number and name sort order will now apply in DocMax Account code list.
