Summary

Reports disciplinary removal data for all students with disabilities.

• A record must be created for each disciplinary removal that includes an Event Identifier, the type of removal, response reason (required for unilateral removals to an Interim Alternative Educational Setting [IAES]), the start date of the removal, the duration of the removal, as well as an indication of whether the student was suspended for the remainder of the school year and if the student received services during suspension. This would be "Y" (Yes) only when the Response Code = "OSS." A student can only have one suspension type at a time. If a student receives both an inschool suspension and an out-of-school suspension for the same incident, they must be reported separately with different start dates and Event Identifiers.

Due Dates

- Districts should begin reporting data as soon as the SIRS opens in September.
- Data should be reported on a frequent and on-going basis throughout the school year

Scope and Purpose

- · Report disciplinary removal data for all students with disabilities.
 - This template defines the Stud_Infr_Resp fact table. This table tracks the details of Disciplinary Actions (Discipline Responses) taken against a Student as the result of a Discipline Incident.

Functional Requirements

Reporting Population and Business Rules

Reports disciplinary removal data for all students with disabilities.

Requirement
Offender MUST have a Reportable Resolution that is active on at least one date on/between the extract editor Start Date and End Date to report a record
Reportable definition = ISS, OSS, IAES School Personnel, or IAES Impartial Hearing Officer
To report an ISS or OSS removal record:
Student MUST have a Behavior > *Resolution Type mapped to State Code in (ISS or OSS)
To report an IAES School Personnel or an IAES Impartial Hearing Officer removal record:
Student MUST have a IAES Response Code (new field) value selected
Duplicate records may report

#	Rule
1	If supplied, LOCATION CODE must exist in the LOCATION Table for the matching DISTRICT CODE
2	A parameter can be set to require that LOCATION CODE be supplied

3	SCHOOL YEAR DATE is the date of the last day of the school year in ISO format: YYYY-06-30
4	Date fields (field name ends in DATE) must be in ISO format: YYYY-MM-DD
5	RESPONSE DATE may be optionally validated to not be greater than the current date at execution time
6	The School Year of RESPONSE DATE may be optionally validated to match SCHOOL YEAR DATE
7	RESPONSE CODE must exist in the DISC_RESPONSE Table for the matching SCHOOL YEAR DATE
8	If supplied, ADMINISTRATOR ID must exist in the STAFF Table for the matching DISTRICT CODE
9	If both supplied, DISPOSITION END DATE must be greater than or equal to DISPOSITION START DATE
10	If the combination of STUDENT ID and EVENT IDENTIFIER for the matching SCHOOL YEAR DATE is not found in the STUD_INFRACTION Table, the record may be rejected, accepted with warning, or accepted with no warning, based on a load plan parameter
