This association relates students to their parents, guardians, or caretakers. Delaware uses this resource for **all** contacts of the student (e.g. Siblings, Parents, etc.)

Object Triggering Logic

Action	Business Rule(s)
Post	<p>Reports a record when at least one related person is a student.</p> <ul style="list-style-type: none">• Relationship must be active on Today's Date• Do not report a record if any of the following exclusions are present:<ul style="list-style-type: none">○ Enrollment State Exclude○ Enrollment Grade Exclude from State Reporting○ Calendar Exclude○ School Exclude○ Private Relationship• If a relationship is started anytime within a school year, the record will be reported for that year.• If the student's is a guardian of themselves (emancipated), then report the student as both the Parent and the Student.

Delete /Post	A DELETE / POST will be performed if the data element being altered is part of the resource's natural key. A PUT will be performed otherwise.
