TN Ed-Fi Suite 3 API v6.2 Data Standard v4.0: Student School Associations

Summary

This association represents the School in which a student is enrolled. The semantics of enrollment may differ slightly by state. Non-enrollment relationships between a student and an education organization may be described using the StudentEducationOrganizationAssociation.

Object Triggering

Post	<p>When a new enrollment is saved for a student. A record will report for each distinct enrollment in a School and Enrollment Start Date</p> <ul style="list-style-type: none">• When a student has two enrollments in the same School, Calendar & Schedule Structure with the same start date, report from the enrollment service type in the following order:<ol style="list-style-type: none">1. P: Primary Enrollment2. S: Partial/Ancillary3.
