The following list provides general information on standard transaction fees that could be associated with Würk Services. This list is not comprehensive of all costs that could be assessed by Würk. This schedule is provided for informational purposes only and may be changed at any time.

Bank Account Change	Fee assessed for updating client bank account information.	\$100/account change
