#### <u>FY25 Readiness and Environmental Protection Integration (REPI) Challenge Proposal:</u>

Partners: NVRC, Prince William County, and Commonwealth of Virginia

#### <u>Virginia Security Corridor Sentinel Landscape</u>:

- Purpose: Preserve, coordinate, and grow the spaces and conditions vital to prioritizing mission readiness, preparedness for war, and modernizing key capabilities.
- Status: Awarded to the Commonwealth July 2023

#### **Future Opportunities**

<u>Readiness and Environmental Protection Integration (REPI)</u>: Conservation projects and natural resource restoration.

<u>OLDCC MIRR 2.0</u>: NVRC developed Regional Strategies identified in the initial MIRR. The final report was published in Jan 2025. NVRC is currently working with OLDCC to scope a MIRR 3.0.

## MIRR: Beginning to End



- September 2020 Northern Virginia Regional Commission (NVRC) first contact with Office of Local Defense Community Cooperation (OLDCC) regarding application
- October 2020 Submitted first document outlining the need
- November 2020 Scott Spencer assigned OLDCC Project Manager to develop application
- January 2021 Held meetings with Installations and requested Letters of Support, also received Letter of Support from State
- February 2021 Determinations and Findings from OSD General Counsel approval before invited to OLDCC grant portal
- March 2021 Submitted First Draft
- ➤ June 2021 NVRC requested Energy and Water Plans from Installations
- July 2021 Budget Justification and Letter of Certification Submitted
- August 2021 Application Submitted into Grants Portal
- September 2021 Grant Kickoff
- January 2022 MIRR Kickoff
- ➤ May 2023 MIRR Final Report



#### **MIRR: Pitfalls**



#### **OLDCC** Requirements

- > Timely
- ➤ Rewrites required to include Compatible Uses
- > Concerns of covering three bases and three complex counties

#### **Installations Delays**

- > Setting up meetings with all three Installations
- ➤ Letters of Support not forthcoming
- > Refusal to Share Energy and Water Reports

#### **NVRC** Delays

- > Staffing issues and need to hire someone with experience
- Position description for position
- > Contracting




#### MIRR: The need for a regional approach



MIRR Purpose: Comprehensive look at threats and vulnerabilities associated with Climate Change.

#### Regional Approach: Within a ten-mile radius

- ➤ Overlapping Issues:
  - > Transportation along I-95 Corridor
  - Water Sources & Wastewater Drainage
  - > Similarities in storm surge
  - ➤ Electrical Redundancy Systems
- ➤ Regional Solutions Needed:
  - Workforce
  - ➤ Affordable Housing
  - Regional Resiliency inside and outside the gates
