Overview

Summary

Districts are required to report one record per student, per state assessment type, per assessment area/subject, per assessment date on/between the start/end date selected on the extract editor for all tested grade levels.

- The Student Assessment (FA) Extract combines the previous assessment extracts. It reports general assessment information based on the Test settings and the student's score record.
 - There are multiple Assessment Types to choose from when Generating the OH Extracts > Student Assessment (FA) report.
 - Each Type returns in the same format & field order
 - Each Type has unique reporting population requirements
 - Each Type may have Field Logic differences between the Assessment Types generated


