Overview

Summary

Reports at least one record per locked IEP that is active on at least one date in the selected reporting range in which the student receives a Graduation Exemption AND reports one record per locked IEP where the student stops receiving an IEP exemption.

Multiple records may report per IEP enabling the reporting of multiple graduation assessment type/area combinations contained within a single IEP.

NOTE:

- If SPED third party integration is set up then SPED data will be pulled through API, not Infinite Campus.
- If incorrect data is extracted, the district will need to work in their 3rd party system to correct the data so it can be extracted. [Set Up Script and API Documentation](#)

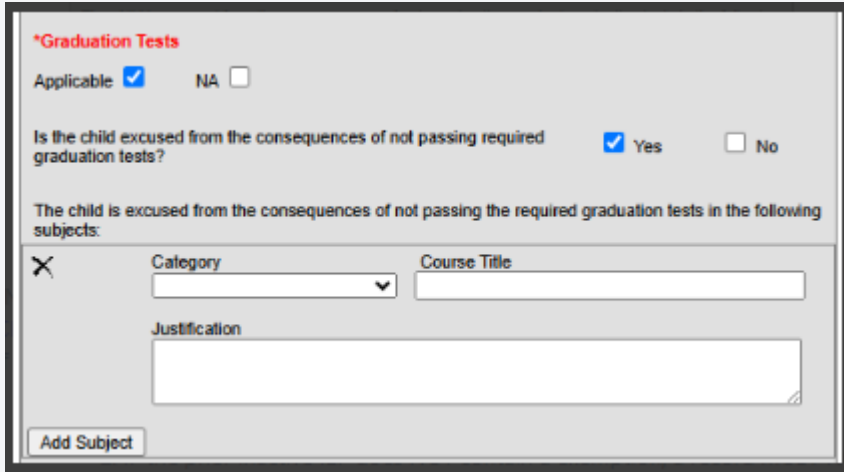
State expects all files submitted as soon as student stops/changes/ends an exemption (All Districts): Critical timeframe is October & Yearend

#	SAMEGOAL - Requirements
R1	Third Party SPED Integration is set up and marked on the Extract Editor
R2	1. Make API call 2. Set parameters a. When calendar is selected, the fiscal year associated with the calendar and the building number should be passed through API. b. When reporting period is selected, the reporting period should be passed through API. c. When start and/or end dates are entered, start and end dates should be passed through API. d. When ad hoc filter is selected, the EMIS Student ID numbers should be passed in the filter though API. 3. Extract data 4. Each record returned would create one record in the report. 5. Records are matched with campus data on EMIS Student ID number
R3	1. Campus applies Post-processing to the file (records) received from API call a. Confirms the student has a reportable enrollment on at least one date during the Fiscal Year i. Enrollment must be in at least one calendar that is not state excluded, with an enrollment that is not marked state excluded or no show, and is not in a state excluded grade level. b. Example: FY26 runs 7/1/25 to 6/30/26

#	Reporting Data from Campus IEP - Requirements 
R1	Reporting Data from Campus IEP - Third Party SPED Integration is NOT set up, neither marked on the Extract Editor
R2	- Reports One record per locked IEP per Graduation Tests > (<i>Exemption</i>) Category selected. - Assumes IEP is active on at least one date in the selected reporting range in which the student receives a Graduation Exemption. (YES record) - Multiple records may report per IEP enabling the reporting of multiple graduation assessment type/area combinations contained within a single IEP.
R3	- Reports ONLY one record per locked IEP when NO graduation test (exemption) Categories are selected AND the 'The child is excused from the consequences of not passing the required graduation tests?' question - YES is marked - Assumes IEP is active on at least one date in the selected reporting range in which the student receives a Graduation Exemption. (YES record) - A UI validation exists where if Yes is selected, a category is required. <i>This UI validation can be over-ridden although it is NOT recommended.</i> <i>Should districts NOT select a category, State required fields may report as Blank/Null.</i>

R4	1. MAY report one record per locked IEP that is active on at least one date in the selected reporting range in which the student STOPS receiving an IEP exemption. (NO record) a. A record MAY report when the student does NOT qualify for an graduation exemption b. <u>Limited NO (Exemption) records report.</u>
R4. BR1	A "NO" record MAY report when <i>"Is the child excused from the consequences of not passing required Graduation Tests?"</i> - Yes = NOT CHECKED <u>and</u> there are NO categories selected. 1. <u>Limit reporting of NO records based on change in exemption status between current & prior IEP:</u> a. If the student's earliest IEP in the reporting range does NOT contain an exemption Category: i. Look at student's last (inactive) IEP prior to the reporting range 1. Only IF the prior inactive IEP contains an exemption Category, report a NO record. 2. IF the prior inactive IEP does NOT contain a exemption Category, a record MUST NOT report b. Look at all sequential/active IEPs in the reporting range that DO NOT contain an exemption Category: i. ONLY if the previous active IEP contains an exemption Category, report a NO record. 1. IF the previous active IEP does NOT contain an exemption Category, a record MUST NOT report
