#### Summary

This resource represents an individual for whom instruction, services, and/or care are provided in an early childhood, elementary, or secondary educational program under the jurisdiction of a school, education agency or other institution or program. A student is a person who has been enrolled in a school or other educational institution.

#### Notes:

- Student records are never deleted because Student records are a shared resource among all districts.
- If two districts have the same student in the same year, the last district to trigger data to Ed-Fi "wins". For example, if one district put in a first name of "Robert" and the second district put in a first name of "Rob" the last district to update the student record is what will appear in Ed-Fi and on both District's reports. This is true for all field logic in the Student Resource except the Identification Code in which the array reports for each district.
- A Student School Association record must be sent in order to see/access a Student record in the ODS. This is is the security protocol set by Ed-Fi. You cannot see the Student record until it has been associated to a School through the SSA record.
