Scope and Purpose

The purpose is to provide data to the state ahead of a student's scheduled taking of an assessment.

This report contains student name and id information

Functional Requirements

Reporting Population and Business Rules

#	Requirement
R1	Report one record per student per subject
R2	If student does not have any Course where Assessment Subject is populated, a blank record will report for the student with Subject and Teacher Name fields blank. If Section > Assessment is not set, report Teacher Name fields blank.
R3	Report students enrolled on effective date of report generation
R4	If Report State Excluded Students checkbox is checked on the Extract Editor, Reports students where enrollment state exclude is checked
R5	If Report State Excluded Students checkbox is not checked on the Extract Editor, do not Reports students where enrollment state exclude is checked
R6	Do not report Enrollments with "No Show" = checked
R7	If a student has two enrollment records, for the same calendar then pull data from the Primary enrollment
R8	If no primary enrollment, then report Special Ed, if no Special Ed, then Report Partial
R9	If a student has two Primary Enrollment records, then report the primary enrollment that is active on the effective date.
R10	There must be at least one Assessment Pre-Code record in the file.

MAPSPR Assessment:

1. Report via course if all of the following is true:
 - a. Student must be rostered into something

 - 3. If the Enrollment set up is not all true, report based on Grade/Enrollment if all of the following is true:
 - a. Student must be enrolled
 - b. Grade (*Student Information > General > Enrollments > Grade*):
 - i. '03'
 - ii. '04'
 - iii. '05'
 - iv. '06'
 - v. '07'
 - vi. '08'

MAP Assessments:

- 1. If Assessment = 'MAPSPR' then StudentGradeLevel must be '03','04','05','06','07', or '08'.
 - Report one record per student in grade 3-8 who is actively enrolled on Effective Date of report generation Extract Editor

- Report codes ELA, MATH and SC for students in grades 05, 08 and 11.
- 2. Now look for courses where Course > Assessment Subject code = ELA, MATH and SC. Report a record for each subject area if the student is enrolled in a course section with the associated assessment subjects.
 - If subject code is null, do not report the primary teacher first and last name and email. These courses will be excluded when subject area is null.
 - If student fits report population but is not rostered in any course where subject area = ELA, MATH or SC, report one record for the student with the fields associated with course and section data reporting blank.
- 3. When Course > Assessment Subject code = ELA, MATH and SC, next, look for sections where assessment type = MAPSPR. Report the primary teacher's email and name data from that section. (section must have the subject type associated with it for multiple records to report)
 - If Course > Assessment Subject code = ELA, MATH and SC but no section has assessment type = MAPSPR, report a record for students enrolled in Course > sections but report associated teacher data as blank.

EOCSPR, EOCFAL and EOCSUM Assessments:

- If Assessment Type = 'EOCSPR', 'EOCFAL', or 'EOCSUM' then:
 - Reports students in "any HS grade" - selected in Extract Editor
 - Assessment Type must be defined on the Section Editor of a course.
 - It appears that, if there is no Teacher or Primary Teacher record associated with a specific, otherwise-reportable course/section, the record is totally excluded from the output
 - Course Assessment Subject = 'ENGLI2','ALGEB1','BIOLO1','AMGOV1'

LEP/ELL Assessment:

- If Assessment Type = LEP/ELL students can be any grade level K-12.
 - Logic will be used to determine LEPELL Pre-code records:
 - First, determine the student's LEPELL status-
 - For any actively enrolled student, in grade levels K-12, consider any LEP record where the First Year Monitoring date is NULL:
 - If the Program Status = LEP **OR** Pending, return a record in the extract for that student
 - LEPELL TstMethod is hard coded as PENPAP.

EOCEXP: EOC Assessment:

- If Assessment Type = EOCEXP: EOC Exceptions then StudentGradeLevel MUST be '12'.
 - ONLY students with an active enrollment on the effective date selected on the extract editor where grade = 12
 - May be 0-4 records per student, with up to 1 record per student for each of the 4 required EOC Assessment subjects for which an exception result is returned

- Required EOC Assessment subjects are reported in the Subject extract field and the state codes include ENGLI2, ALGEB1, BIOLO1, AMGOV1. These subject codes **MUST** be set up on the assessment or else the student will not report.
 - Do not return > 1 record for each the above state codes per student in the Subject field
 - Sort file by student's last and first name
- Return 1 record per assessment with an exception result where:
 - ☐
 - - Assessment> Test> Test Detail> State Code = EOC **AND**
 - student's Assessment> Test Scores> Test Score Detail> Result = EOCEX1 or EOCEX2 or EOCEX3 or EOCEX4
 the extract's Assessment field should return the Exception code selected. *report all such EOC exception results with any date for students in the reporting population.*
 - OR**
 - Return 1 record per student for each of the 4 required EOC assessments (4 total per student) where:
 - Student Info> General> Enrollments> Special Ed Fields> Map-A = checked with the extract Field: Assessment returning value = EOCEX3
 - Required EOC Assessment Subject Codes include ENGLI2, ALGEB1, BIOLO1, AMGOV1
 - Return 4 records per student where Map-A = checked, one for each of the above state codes in the Subject field
 - Each of the 4 records return with the Assessment field value = EOCEX3

ACT: ACT Assessment:

- If Assessment Type = ACT: ACT, Reporting population =
 - a. Report all 11th grade students (State Grade = 11 : Eleventh Grade) actively enrolled in the Calendar selected for reporting as of Effective date of report generation.
 - b. Report one record per 11th grade student. If the student has more than one enrollment with the same FTE and the same enrollment type in different schools, the latest school of enrollment will report.
- 1. First report from enrollment with the highest *Percent Enrolled(Out of 100) (state reporting fields) as of effective date of report generation.
 - a. If there are multiple enrollments where Percent Enrolled is equal report from enrollment where service type = P : Primary.
 - i. If no primary enrollment, report from enrollment where service type = S : Partial.
 1. If no partial enrollment, report from enrollment where service type = N : Special Ed Services
 - a. Finally if there are multiple enrollments with the same date after the above logic, report from the highest enrollment ID.
 - b. If only one school is selected when generating the report, report the 11 graders enrollment in that school with the above logic
 - c. If multiple schools are selected when generating the report and the student has enrollments in different school, use the above logic to report only one record per 11th grade student

2. Do not report students in Calendars checked exclude or state excluded students (state reporting fields > State Exclude) or students marked No Show on their enrollment.
- c. Fields 115, Test Method - field 155, Examiner Email will all report blank.

When Assessment Type is EOCEXP: EOC Exception, the return value is pulled from the Test Detail in one of two ways, depending on user setup:

1. Look for the following user-entered state codes in System Admin> Custom> Attribute/Dictionary> Test> Test Type> Dictionary Detail- If the state codes are not entered on the Dictionary Detail as described above, **return value is mapped to the Subject from the Test Detail as follows:**
 - a. ENGLI2
 - b. ALGEB1
 - c. BIOLO1
 - d. AMGOV1
 - If ALL state codes are entered in the Dictionary Detail, **return value is state code for user entry on the System Admin> Assessment> Tests> Test Detail> Subject**
