Summary

This event entity represents the recording of whether a student is in attendance for a class

Object Triggering Logic

Action **Business Rule(s)**

Post

Reports a record when an attendance event is given to a student **AND** the attendance status + attendance excuse is mapped to an Ed-Fi Code

OR

Reports a record when the student is in a Blended Learning Group (BLG) and the BLG has an event on the calendar for the reported date.

- Do not report a record if the any of the following exclusions are present:
 - Enrollment State Exclude
 - o Enrollment No Show
 - Enrollment Grade Exclude from State Reporting
 - Enrollment State End Status of D1, D2, or D3
 - Calendar Exclude
 - Calendar Summer School
 - School Exclude
 - Course Attendance not checked
 - Course State Exclude
 - Course Active not checked
 - Course State Code is Blank (NULL)
- The student must have a Student Section Association record to report.
- The Attendance date must fall on or between enrollment start and end dates to report.
- A record will send for each distinct Date, Section, and Attendance State Code.

Delete /Post	A DELETE / POST will be performed if the data element being altered is part of the resource's natural key. A PUT will be performed otherwise.
Put	When any of the following information on a student's Attendance changes:
	 Code When any of the following information on the Enrollment changes:
	 Start Date End Date State Exclude No Show When any of the following information on the Section changes: Section Placement (Class Periods / Terms the Section is offered in) When any of the following information on the Course / Course Master changes: Attendance Active State Code State Exclude Changes to the scheduled time of a period do not trigger. Reports RMTEATTD if the student is part of a Blended Learning Group that has a calendar event for the day and the student has no reportable attendance codes for the period. Reports the Ed-Fi Code mapped to the Attendance Status - Attendance Excuse combo used on the Attendance Code given to the student for the section. If the student receives multiple statuses for the same section (e.g. Section spans multiple periods) then they will receive a record for each unique Ed-Fi Code.
