What's New

1. New Search Field – Building Locked

A new search field is now available in DocMax and BCMax Building searches. This will filter locked or unlocked buildings based on whether 'Yes' or 'No' value is set for the search.

Field	Condition	Value

The search is available for DocMax Advanced Search and Work Queues. This is particularly useful when creating Creditor Invoice Work Queues so documents for locked buildings will not show in the queue.

Work Queue will contain documents with:

Categories is any of Invoices



3. DocMax – Lost Buildings

DocMax will now allow documents to be added to lost buildings. This process should be used with caution. For example, if 'Upload to Portal' is set in document properties, the document will remain in pending upload.

What's Better

- Report Distribution – Auto Error was appearing when the proceed button was being pressed before the form had fully initialised. This has now been resolved by disabling proceed utilisation.
- DocMax – Work Queues – Issue around remove actions has been resolved.
- Periodic Payments – System prevents double clicking save issues.
- Bank Transaction Report – Other Investments Accounts balances were displaying incorrectly or not at all. Other Investments accounts have now been excluded from the Bank Transaction Report.
- Roll Plan Report – Plan number was not displaying correctly for Lot number. This has been resolved.
- Code Change Number – Issue when processing a code change for a Creditor Account Code has been resolved.
- Levy Management – issue occurring when approving Levies with no entitlements. Validation message has now been added to Levy Management.
- Payments Management Preview - View Payments and a document preview window have been added to the Payments Management Preview Feature
