Summary

This association represents the School in which a student is enrolled. The semantics of enrollment may differ slightly by state. Non-enrollment relationships between a student and an education organization may be described using the `StudentEducationOrganizationAssociation`.

Data Validation Report (Ed-Fi Student School Associations Validations)

This report will return the following validations (Reporting > Data Validation > Data Validation Report):

- Entry Date must be within the school year

- Withdrawal Date must be within the school year
- Withdrawal Date must be greater than or equal to Entry Date
- No primary enrollment exists but secondary enrollment does exist
- Student cannot have more than one School Association with Enrollment Reason Code of E or E1 in a single school year
- Student cannot have TR Enrollment Reason Code if there is not existing E or E1 at a different school in a single school year
- Student cannot have more than one enrollment reason code in a single school year
