Object Triggering

Action	Business Rule(s)
Post	<p>When a student is scheduled into a course section</p> <ul style="list-style-type: none"> • A record will report for each Section record that is reported based on the Sections logic • If roster start date is after the term end date, do not report a record for the prior term • Only send records if the student has a enrollment in the schedule structure where the student is scheduled and is not marked as No Show • Do not send records if the Calendar Exclude check box is checked • Do not send records if the School Exclude check box is checked • Do not send records if the Course is marked as Inactive
Put	<p>When section information is updated for a student or section</p> <ul style="list-style-type: none"> • Update when the course or section's homeroom field is changed
Delete /Post	<p>When student's roster start date is changed</p>
Delete	<p>When a student is deleted from a course section</p> <p>Delete any future records if the student is given a roster end date for the course</p> <ul style="list-style-type: none"> • Roster End Date must be before Term Start date of future records
