
1. Meeting synchronisation

Meeting and ballot information in Meeting Hub is now automatically synchronised with BCMax, keeping meeting details and distributed documents aligned across both systems.

2. New controls- reviewing, updating, and withdrawing pre-meeting VoteMax votes

VoteMax now gives lot owners and managers greater control and visibility over pre-meeting voting, making it easier to review, update, and manage declared votes before a meeting commences.

- Managers can withdraw votes declared via VoteMax in Meeting Hub, when required
- Improved prompts in VoteMax guide users to declare votes so they are included in vote counts.





What's Better

- Meeting Hub alerts have been enhanced to ensure managers are only warned when multiple votes from the same lot are in conflict.
- Meeting Hub now alerts managers when updating a voter's eligibility would cause more than one vote from the same lot to be included in vote counts.
- An issue where updated meeting dates or times were not always saved when closing a meeting has been resolved.
- The Close Meeting screen in Meeting Hub has been refined to improve reliability when updating the meetings close date and/or time.
