Action	Business Rule(s)
Post	<ul style="list-style-type: none"> • When Rule 18 program and a student transcript record are created in the calendar's configured year • Rule 18 program record must overlap the calendar's config year • Student must have a transcript record with teacher number field populated which overlaps the calendar's config year • Do not send a record if the Rule 18 Program is assigned to a student with enrollment in a calendar or school that is marked exclude
Delete/Post Put	<p>A DELETE / POST will be performed if the data element being altered is part of the resource's natural key. A PUT will be performed otherwise.</p>
Delete	<ul style="list-style-type: none"> • When the enrollment is marked State Exclude, No Show • When the enrollment determining the record is deleted • When part of the records' Natural Key changes • When the Rule 18 Program is deleted or when the record no longer overlaps the configured year

Action	Business Rule(s)
Post	<ul style="list-style-type: none"> • When a new blended learning group is created and the status is set to Active and at least one student is assigned to the Blended Learning Group • A separate record will be sent for each school where there is at least 1 student added to the group based on the school of the student's enrollment • Do not send a record if the Blended Learning Group is only assigned to students with enrollments in a calendar that is marked exclude • Do not send a record if the Blended Learning Group is only assigned to students with enrollments in a school that is marked exclude
Delete/Post Put	<p>A DELETE / POST will be performed if the data element being altered is part of the resource's natural key. A PUT will be performed otherwise.</p> <ul style="list-style-type: none"> • Update modalityTypeDescriptor when a Blended Learning Group is either assigned to a calendar day or removed from all calendar days in a school. • Recalculate modalityTime whenever a Blended Learning Group is either added or removed on the Calendar Days.
Delete	<ul style="list-style-type: none"> • When the enrollment is marked State Exclude, No Show • When the enrollment determining the record is deleted • When part of the records' Natural Key changes • When a Program is deleted or when the record no longer overlaps the configured year
