Logic for reporting from EL Record

1. Logic for reporting from EL Record

- a. From the identified EL record, calculate the reported value
 - i. If there is an 'English Proficiency Override' value on the EL record used (see above for logic on which record to use), report that value
 - ii. If no English proficiency override exists AND the student has exited EL Status and the Exit date is prior to the current date/ end of year date, report '6'.
 - iii. Else find an EL Assessment of Assessment Type 'LPF' or 'LID'
 1. If the student's EL Identified date is prior to the start date of the school year use the most recent assessment score in the prior year or earlier if they have no assessments in the prior year
 - a. Score must be on the parent assessment
 - b. This score must report through the end date on index>system admin> calendar>school years> end date
 - i. IF Null report this through 6/30/current year

If the student is a new EL student, use the current school year's earliest assessment score
